We use cookies on this website.

## What are cookies?

A cookie is a small text file that our website requests to be saved on the visitor's computer, tablet or mobile phone.

Cookies can be stored in two ways. Session cookies are temporarily stored on your device when you visit our website and are deleted when you close your web browser. Persistent cookies are stored on your device for a specific period of time or until you delete them. Furthermore, cookies can be divided into first-party cookies, which are placed by us, and third-party cookies which are placed by someone else. Our website uses both types.

## Strictly necessary and other cookies

Cookies that are strictly necessary for our website to function cannot be deactivated via our cookie-settings. We have a legitimate interest to use these cookies for purpose of providing our website and ensure the security of our network.

Other cookies, for example those used for marketing purposes or to analyse how you use our website requires your consent. These cookies are deactivated by default.
